

1	Claim(s)1-8 fall(s) within the scope of such clause (p) of section 3 of Patents Act 1970 as amended by Patents (A) Act 2005 in view of TKDL search results 1) AB/171/Asokaghrtam 2) RG9/122B Amalaki Majja Guna.
2	Claims do not sufficiently define the invention w.r.t. the term "combination of plants" and there are so many formulations can be prepared by combining the organic extracts of plants disclosed in claim-1. Hence, Claims shows plurality of inventions.
3	The word "organic extract of Syzygium cumini, Trigonella foenumgraceum ,Hippophae rhamnoides ,Centella asiatica , Aegale marmelos , benincasa hispida ,Curcuma longa,Bacopa monnieri,Terminalia chebula,Emblica officinalis,podophyllum hexandrum,withania somnifera ,Valeriana jatamansi,Asparagus racemosus" makes the claim not definitive as the active ingredients of organic extracts and plant part are not disclosed .
4	Claim-1 fall(s) within the scope of such clause (e) of section 3 of Patents Act 1970 as amended by Patents (A) Act 2005.
5	Claim 2-7 are redundant in view of claim-1.
