If not indicated otherwise the relevant passages are those mentioned in the search report.

Document D1 discloses steroidal saponin extracted from *Homonoia riparia* by percolation with 30% ethanol for use in the treatment of purine metabolism disorders inter alia caused by diabetic ketoacidosis (see annexed machine translation at page 3 middle of second paragraph).

Document D2 discloses a composition comprising *Homonoia riparia* root for treating inter alia diabetes mellitus.

Document D3 discloses the use of *Homonoia riparia* for treating kidney troubles, bladder stones or genito-urinary tract disorders.

Document D4 discloses the use of *Homonoia riparia* as laxative, diuretic or for treating bladder stones.

- 2 Novelty (Art. 54 EPC):
- 2.1 The diseases treated according to D1 can be caused by diabetic ketoacidosis (see annexed machine translation at page 3 middle of second paragraph) and thus fall in the scope of the terms *diabetic complications*. The disclosure of D1 anticipates thus claim 1. The terms *health functional food* do not characterize the composition of claim 2, claim 2 lacks thus novelty over D1.
- Due to the wording "comprising", it appears that the composition of D2 falls in the scope of claims 1 and 2. The treatment of diabetes results as well in the prevention of the diabetic complications. Hence, claims 1 and 2 lack novelty in view of D2.
- 2.3 Dependent claims 3-14 does not appear to contain any additional features which, in combination with the features of any claim to which they refer, meet the requirements of the EPC with respect to novelty and/or inventive step.

The use of an alternative extraction process differing from that of D1 does not confer novelty to the *Homonoia riparia* extract. When treating diabetes as disclosed in D2, the diabetic complications of claim 9 are also treated. Claims 3-14 appear thus to lack novelty in view of D1 and D2.

Claims 1-14 do not fulfil the requirements of Art. 54 EPC.

3 Art. 84 EPC:

Despite the different wording of claims 1 and 2, the scope of the claims is the same. Claims 1 and 2 are thus redundant.
